



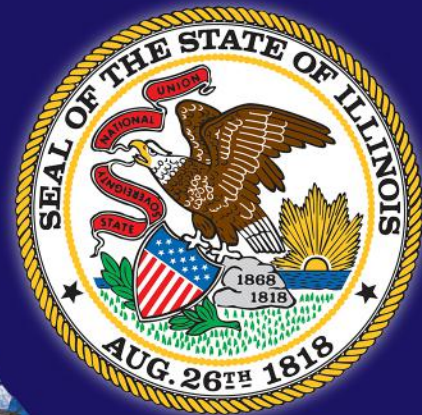

I am pleased to present the 2022 Annual Report (the “Report”) of summary statistical information produced by the Department of Financial and Professional Regulation (the “Department”) pursuant to Public Act 100-286. The Act aims to ensure that having a criminal conviction alone does not stand in the way of occupational licensure, and requires the Department to consider mitigating factors and evidence of rehabilitation contained in the applicant’s record. Indeed, this law’s objective remains at the heart of the Department’s core mission and philosophy: to remove barriers of entry and to ensure that all Illinoisians have a fair opportunity to work in the professions that they have trained so hard to practice in.

As with years past, the Report illustrates that virtually all applicants with criminal convictions, that by law did not automatically exclude them from licensure, were awarded licenses. The small percentage of applicants with convictions who were not granted licenses were due to factors unrelated to the conviction; for example, voluntarily electing not to pursue the application process further. Overall, in 2022, the Department received more than 110,000 license applications, about 1,850 of which reported past criminal history. Only 3 applicants were denied a license, in whole or in part, because of their conviction.

In addition to the general trend of awarding licenses to applicants with criminal convictions, this year’s Report illustrates the success of Illinois’s statutory framework to establish social equity in the cannabis industry. The Cannabis Regulation and Tax Act established a model framework for the nation in part by removing employment barriers in the cannabis industry for persons with convictions, and incentivizing the employment of persons with such convictions. The Report shows that approximately 30% of all agents applying for licenses to work in an adult use cannabis dispensary applied with a criminal conviction. No one who applied with a non-excluded conviction was denied a license.

Although the Report shows that a non-excluded conviction rarely prevents a license from being granted, we must still work hard as an agency to make our application process seamless. To this end, the Department routinely reviews our processes and procedures to ensure we are reaching the gold standard for public service. We continue to think about how to effectively communicate key information about the application process with applicants who have convictions. We are also strengthening our partnerships to help facilitate licensure upon release, including working alongside the Illinois Department of Corrections and participating in re-entry summits. Finally, we are working to make critical technological improvements that allow the Department to provide excellent customer service to our constituents overall.

The Report underscores the Department's ongoing commitment to apply fair, unbiased, and even-handed mitigating factors in the licensing process, so that having a past criminal conviction is rarely, in and of itself, a bar to obtaining a professional license. The Department, therefore, continues to encourage qualified applicants with previous convictions to apply and seek their license, which is ultimately to the benefit of all in Illinois who will receive their services.

## INTRODUCTION

P.A. 100-286 amended the Civil Administrative Code of Illinois for the Department requiring it to prepare, publicly announce, and publish an annual report for the preceding calendar year that includes the following information for professions under the Department's jurisdiction:

- Number of applicants for a license, certificate, or registration
- Number of applicants who had a criminal conviction
- Number of applicants who received a license, certificate, registration
- Number of applicants who received a license, certificate, or registration who had a criminal conviction
- Number of applicants who were denied a license, certificate, or registration
- Number of applicants who were denied a license, certificate, or registration in part or in whole because of a criminal conviction, including the types of criminal convictions
- Number of licenses issued on probation with a criminal conviction
- Number of licensees or certificate holders granted an expungement for a record of discipline based on a conviction predating licensure, certification, or registration or a criminal charge, arrest, or conviction that was dismissed, sealed, or expunged or did not arise from the regulated activity, as a share of the total of such expungement requests

This report, as required by P.A. 100-286, is to be completed no later than May 1 of each year. This Report is made using applicant data from the period of January 1, 2022, through December 31, 2022. Please note an applicant who may have begun the application process during this time may not have completed the process by December 31, 2022, or a decision may have been issued on an application in 2022 that was submitted in the year prior.
