## ORDER VACATING THE ENTRY OF A PREVIOUS ORDER

WHEREAS, the Secretary of the Illinois Department of Financial and Professional Regulation (the "Secretary"), conducted an examination of facts related to EZ 123 Pawn Shop, 270 W. North Avenue, North Park Mall, Villa Park, Illinois, and found that EZ 123 Pawn Shop has committed violations of Sections 0.05(c) and 1.5 of the Pawnbroker Regulation Act [205 ILCS 510/0.05(c) and 205 ILCS 510/1.5] (the "Act");

**WHEREAS**, on March 18, 2005 the Secretary issued an ORDER pursuant to the authority provided by Section 0.05(a)(6) of the Act [205 ILCS 510/0.05(a)(6)], imposing a Civil Monetary Penalty in the amount of \$750.00 against EZ 1234 Pawn Shop;

WHEREAS, subsequent to the issuance of the March 18, 2005 Order imposing a Civil Monetary Penalty, EZ 123 Pawn Shop submitted an application to become licensed in the State of Illinois as a pawnbroker and pursuant to the Division of Banks and Real Estate Administrative Rule Part 360, [38 Ill. Adm. Code, Part 360], paid an application fee in the amount of \$756.00 to the Illinois Department of Financial and Professional Regulation;

**WHEREAS**, EZ 123 Pawn Shop has determined that it will voluntarily withdraw the above referenced application to become a licensed pawnbroker in the State of Illinois and forfeit the application fee in the amount of \$765.00 to the State of Illinois;

WHEREAS, the referenced Civil Monetary Penalty previously imposed by the Secretary was

intended to penalize EZ 123 Pawn Shop in an amount commensurate with the license application fee

that EZ 123 Pawn Shop would have been required to pay for the period of time that EZ 123 Pawn

Shop operated as an unlicensed pawn shop in violation of the Pawnbroker Regulation Act; and

**WHEREAS**, the Secretary has determined that the Civil Monetary Penalty previously

assessed pursuant to the Order Imposing a Civil Monetary Penalty has been satisfied by means of EZ

123 Pawn Shop forfeiting the referenced application license fee to the State of Illinois.

**NOW THERFORE**, it is hereby Ordered, that the prior Order Imposing a Civil Monetary

Penalty against EZ 123 Pawn Shop on March 18, 2005 shall be, and hereby is, vacated nunc pro tunc.
