ORDER ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banks and Real Estate, (the "Department"), having conducted an examination of the facts related South Suburban Mortgage, Corp., (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987, [205 ILCS 635] (the "Act") and the rules promulgated under the Act [38 Ill. Adm. Code 1050] (the "Rules"), hereby issues this ORDER pursuant to the authority provided under Section 4-5(h)(5) of the Act. The Department makes the following:

FINDINGS

1. That South Suburban Mortgage Corp., is an Illinois residential mortgage Licensee holding License No. MB.0004619 and located at 19630 Governors Highway, Flossmoor, Illinois, 60422; and
2. That Licensee failed to provide proof to the Department of completion of continuing education requirements for five (5) loan officers for 2004 during its license renewal.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

1. That Licensee violated Section 1050.2120 Continuing Educational Requirements for Loan Originators) of the Rules for calendar year 2004; and
2. That Licensee's therefore is in violation of Section 4-5(i) (11) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED:

1. That South Suburban Mortgage Corp. License No. MB.0004619, shall be and hereby is assessed a fine in the amount of \$2,500;
2. The fine in the amount of \$2,500 shall be due within thirty (30) days after the effective date of this Order unless South Suburban Mortgage Corp. shall enter into an agreement with the Department providing for an alternative payment schedule; and
3. The fine in the amount of \$2,500 shall be paid by means of a certified check or money order made payable to the:
