**ORDER ASSESSING FINE**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banks and Real Estate, (the "Department"), having conducted an examination of the facts related to Solutions Funding, Inc., 314 W. Institute Place, Suite 2W, Chicago, Illinois, 60610, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987, [205 ILCS 635] (the "Act"), and of the rules promulgated under the Act [38 Ill. Adm. Code 1050] (the "Rules") hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

**FINDINGS**

1. That Solutions Funding, Inc. is an Illinois residential mortgage Licensee holding license MB.0004223 and located at 314 W. Institute Place, Suite 2W, Chicago, Illinois, 60610; and
2. That the Department has received a copy of an advertisement regarding Solutions Funding, Inc., and the Department has found that the Licensee failed to include the current annualized rate (APR), and state "Illinois Residential Mortgage Licensee."

**CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

1. That Licensee failed to comply with Section 1050.940 of the Rules and Section 3-3 of the Act; and
2. That Licensee is therefore in violation of Section 4-5(i)(11) and (17) of the Act.

**ORDER**

NOW THEREFORE IT IS HEREBY ORDERED:

1. That Solutions Funding, Inc., License No. MB.0004223, shall be and hereby is assessed a fine in the amount of \$500.00 pursuant to Section 4-5(h)(5) of the Act;
2. The fine in the amount of \$500.00 shall be paid no later than thirty (30) days after the effective date of this Order upon Solutions Funding, Inc.; and
3. The fine in the amount of \$500.00 shall be paid by means of a certified check or money order made payable to the:
