**ORDER RESCINDING REVOCATION**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking, (the "Department"), having reviewed matters related to Nations Home Funding, Inc. (the "Licensee") hereby issues this ORDER pursuant to said authority provided under Section 4-5 of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and rules promulgated thereunder (the "Rules") [38 Ill. Adm. Code 1050]. The Department makes the following:

**FINDINGS**

1. That Nations Home Funding, Inc. is an Illinois residential mortgage licensee holding license number MB.6759520 (the "License") and located at 761 Old Hickory Boulevard, Suite 400, Brentwood, Tennessee 37027;
2. That on August 16, 2007, the Department issued to Licensee Order No. 2007-MBR-111 revoking the License whereupon Licensee timely filed a request for hearing on the administrative decision; and
3. That prior to said hearing, Licensee submitted all required documentation to come into compliance with the Act and Rules and for purposes of surrendering the License.

**CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

That Licensee is in compliance with the Act and Rules.

**ORDER**

NOW THEREFORE IT IS HEREBY ORDERED:

That Department Order No. 2007-MBR-111, shall be and hereby is rescinded.
