ORDER REVOKING LICENSE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking, (the "Department"), having conducted an examination of the facts related to Acoustic Home Loans LLC, 770 The City Drive South #1500, Orange, California, 92868, (the "Licensee"), and having found that the Licensee committed a violation of the Residential Mortgage License Act of 1987 [205 ILCS 635] (the "Act"), and of the rules promulgated under the Act [38 Ill. Adm. Code 1050], (the "Rules") hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

- 1. That Acoustic Home Loans LLC, is an Illinois residential mortgage licensee holding license No. MB.6759100 and located at 770 The City Drive South #1500, Orange, California, 92868;
- 2. That Acoustic Home Loans LLC, made a written request to the Department of its request to surrender its residential mortgage license;
- 3. That on May 16, 2006, the Department sent to Acoustic Home Loans, LLC, a letter notifying Licensee that further documentation must be provided for the completion of the surrender process;
- 4. That the Department has received no response to the letter sent to Licensee via U.S. first-class mail service; and
- 5. That the Licensee has failed to provide the requested information and/or documentation due by the due dates requested by the Department.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND

CONCLUDES:

Notwithstanding notices and other efforts by the Department, Licensee has failed to properly surrender its license in violation of Section 2-6(e) of the Act, and is in further violation of

Section 4-5(i)(17) of the Act.

<u>ORDER</u>

NOW THEREFORE IT IS HEREBY ORDERED that the license of ACOUSTIC HOME LOANS, LLC,

License No. MB.6759100 is revoked by Order of the Department pursuant to Section 4-5(h)(1) of the

Act for failure to comply with the provisions cited herein of the Act and Rules, effective ten days after

receipt of this Order, unless you request a hearing pursuant to the RMLA and Subpart N of the Rules,

including remitting the hearing fee required by Section 1050.270 of the Rules.
