ORDER ASSESSING FINE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the “Department”), having conducted a review of activities conducted by **ECILoan.com, Inc**, (the “Licensee”) and having documented violations of the Residential Mortgage License Act of 1987 (the “Act”) [205 ILCS 635] and the rules promulgated under the Act (the “Rules”) [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5 of the Act. The Department makes the following:

FINDINGS

1. That .com, Inc is an Illinois residential mortgage licensee holding license number MB.6759744 (the “License”), and located at 40 Sharpe Drive, Cranston, Rhode Island 02920;
2. That Licensee has failed to perform one or more of the requirements of the Act and Rules described below:
 - a. Failure of Licensee to maintain Surety Bond & Fidelity Bond (205 ILCS 635/3-1) and (38 Ill Admin. Code 1050.490);
3. That the Department made efforts as described below to advise Licensee of these unfulfilled requirements so that Licensee can comply with the Act and Rules:
 - a. That on September 12, 2007, the Department sent to Licensee a letter via U.S. mail service advising Licensee that the surety bond on file with the Department had expired on September 1, 2007;
 - b. That the Department has knowledge that coverage of the \$100,000 fidelity bond or continuation certificate on file with the Department expired on October 31, 2007, and that such current bonds must be submitted to Department within 10 days;

- c. That a Potential Disciplinary Letter was sent to Licensee on November 14, 2007 via U.S. first-class mail service and certified mail. A signed receipt card evidencing receipt of such delivery was received by the Department on November 29, 2007; and
- d. That Licensee has not submitted to the Department a current surety bond and fidelity bond by the due date.

CONCLUSIONS

BASED UPON THE ABOVE FINDINGS THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

1. That notwithstanding notices and other efforts by the Department, Licensee failed to maintain current surety and fidelity bonds; and
2. That Licensee is in violation of Section 3-1 of the Act and Section 1050.490 of the Rules, and is in further violation of Section 4-5(i)(11) and (17) of the Act.

ORDER

NOW THEREFORE IT IS HEREBY ORDERED:

1. That ECILoan.com, Inc, License No. MB.6759744 shall be and hereby is assessed a fine in the amount of \$5,000;
2. The fine in the amount of \$5,000 shall be paid no later than ten (10) days after service of this Order upon ECILoan.com, Inc; and
3. The fine in the amount of \$5,000 shall be paid by means of a certified check or money order made payable to the:
