**ORDER REVOKING LICENSE**

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION, Division of Banking (the "Department"), having examined activities conducted by Brinkman Mortgage Group, Inc. (the "Licensee") and having documented violations of the Residential Mortgage License Act of 1987 (the "Act") [205 ILCS 635] and the rules promulgated under the Act (the "Rules") [38 Ill. Adm. Code 1050], hereby issues this ORDER pursuant to the authority provided under Section 4-5(h)(1) of the Act. The Department makes the following:

**FINDINGS**

1. That Brinkman Mortgage Group is an Illinois residential mortgage licensee holding license number MB.6759195 (the "License") and located at 8845 West 87<sup>th</sup> Street, Suite C, Hickory Hills, Illinois 60457;
2. That on May 2, 2007, the Department conducted an examination of Licensee and the examiner found several violations;
3. That on May 14, 2008, the Department sent to Licensee a Report of Examination Letter via U.S. first-class mail service, with a request for a scheduled supervisory meeting with the Department to be held on July 8, 2008;
4. That on July 8, 2008, the Department sent to Licensee a letter via U.S. first-class mail service advising Licensee that Licensee did not attend its scheduled supervisory meeting, nor did Licensee telephone, nor request a new meeting date; therefore the supervisory meeting had been re-scheduled to be held on July 14, 2008;
5. That on July 14, 2008, Brinkman Mortgage Group, Inc. failed to attend its second scheduled mandatory meeting with the Department;

6. That on September 2, 2008, the Department sent Licensee a Potential Disciplinary Letter by U.S. registered return receipt requested mail, and on September 8, 2008 received the letter back from the U.S. Postal Service marked "Return to Sender;" and
7. That the Licensee has failed to correct violations cited in the Report of Examination, failed to respond to supervisory letters and to attend mandatory supervisory meetings, and failed to provide current address to accept Department correspondence.

### **CONCLUSIONS**

BASED UPON THE ABOVE FINDINGS, THE DEPARTMENT IS OF THE OPINION AND CONCLUDES:

That notwithstanding notices and other efforts by the Department, Licensee is in violation of Sections 1-4(d)(6)(a), 2-4(s) and (t), 3-5, and 4-1(r) of the Act and Sections 1050.410, 1050.480, 1050.1010, 1050.1020, 1050.1110, 1050.1120, 1050.1175, 1050.1230, 1050.1305, and 1050.1350 of the Rules, and is in further violation of Sections 4-5(i) (11) and (17) of the Act.

### **ORDER**

NOW THEREFORE IT IS HEREBY ORDERED that the license of Brinkman Mortgage Group, Inc., License No. MB.6759195 is revoked by Order of the Department pursuant to Section 4-5(h) (1) of the Act for failure to comply with the provisions cited herein of the Act and Rules, effective ten days after receipt of this Order, unless you request a hearing pursuant to the Act and Subpart N of the Rules, including remitting the hearing fee required by Section 1050.210 of the Rules.
