**Springfield, Illinois** – Leonard A. Sherman, Director of the Illinois Department of Professional Regulation, announced the following disciplinary actions taken by the Department during the month of **October 2000**.

**ACCOUNTANT**

**Andrew Greenwald, Highland Park** – public accountant license (065-003525) reprimanded after allegedly making accounting assertions in sworn statements in civil litigation regarding initial contributions of a fifty percent shareholder in a corporation without sufficient supporting evidence, and performing and billing for accounting services after being terminated by that shareholder and while acting as executor for the estate of the other shareholder.

**Robert Elden Lichty, LeRoy** – public accountant license (065-013450) reprimanded for issuing a government audit report, which was not in compliance with current government auditing standards, while his license was non-renewed.

**ARCHITECTURE**

**Jeffrey Finkle, Des Plaines** – architect license (001-005719) suspended for two months and fined \$1,000 for allegedly signing and sealing a set of construction documents represented as a “permit set,” when the construction had already been completed.
