**Springfield, Illinois** – Fernando E. Grillo, Secretary of the Illinois Department of Financial and Professional Regulation, announced the following disciplinary actions taken by the Division of Professional Regulation during the month of **June 2004**.

## ACCOUNTANT

**Robert E. Allgyer, Lake Forest** – public accountant license (065-010198) indefinitely suspended after he was denied privileges of appearing or practicing as an accountant before the U.S. Securities and Exchange Commission.

**Howard R. Benditzson, Northbrook** – public accountant license (065-006662) reprimanded for giving incorrect advice to a client regarding termination of the client's qualified small business retirement plan and the requirement of filing annual reports for the plan, and giving incorrect advice regarding corrective procedures for unfiled reports.

**Brian Joseph Cox, Hinsdale** – public accountant license (065-013378) indefinitely suspended after being disciplined in Michigan.

**Michael E. Wright, Gurnee** – ordered to cease and desist from holding himself out as a "CPA" or "Certified Public Accountant" in Illinois.
