**SPRINGFIELD, IL** - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **June 2006**.

## **BARBER, COSMETOLOGY, ESTHETICS AND NAIL TECHNOLOGY**

**Ramone D. Mason, Chicago** – barber license (006-062282) placed in refuse to renew status due to aggravated criminal sexual assault.

**Linda J. Ciccarelli, Alsip** – cosmetologist license (011-195721) placed on indefinite probation for a minimum of five years due to felony conviction.

**Portia Y Guest, Chicago** – cosmetologist license (011-202742) indefinitely suspended for violating the terms and conditions of a previously imposed probation.

**Lilia Ishu, Glenview** – cosmetologist license (011app225743) issued with reprimand and fined \$500 for operating as a cosmetologist without a license from 2000 through 2005.

## **DENTAL**

Kimmel, Chicago** – dentist license (019-016032) indefinitely suspended for a minimum of one year immediately followed by indefinite probation and fined \$50,000 for providing dental services and things of value in exchange for money and other benefits to prostitutes on behalf of their pimps, assisting in the operation of an interstate prostitution ring from his dental office, billing for services not rendered, patient abandonment, failure to properly diagnose and treat periodontal disease and advertising violations.
