SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Director of the Division of Professional Regulation, Daniel E. Bluthardt, signed the following disciplinary actions taken during the month of **January 2007**.

ACCOUNTANT

Birger C. Nyborg, Roselle - public accountant license (065-007441) suspended for failing to file and/or pay Illinois sales tax and for failure to file income tax returns.

Herbert P. Wasserman, Chicago - public accountant license (065-007560) indefinitely suspended for failure to make a substantive response to a Department request for information regarding a complaint from a former client.

ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

Marvin Holt, Lombard - (unlicensed) ordered to cease and desist the unlicensed practice of architecture.

William Olen, Des Plaines - (unlicensed) ordered to cease and desist the unlicensed practice of architecture and to pay a civil penalty of \$3,000 after he produced architectural drawing for three separate residential construction projects in Illinois, then used the seal of a licensed architect on the plans without authorization. The plans were not prepared by a licensed architect or under the direct supervision of a licensed architect.
