IDFPR Disciplinary Actions for August 2007

SPRINGFIELD, IL - The Illinois Department of Financial and Professional Regulation (IDFPR) announced today that the Directors of the Divisions of Insurance, Michael T. McRaith, Professional Regulation, Daniel E. Bluthardt, and Banking, Jorge Solis signed the following disciplinary orders in August, 2007. Division of Insurance

Mike W. Ingram, Rockford – insurance producer license denied effective August 8, 2007. His application for a limited lines producer license was denied as a result of an investigation, which revealed that the applicant was convicted of felony Aggravated Criminal Sexual Abuse in 1989.

Max Eugene Olds, Wyanet – insurance producer license revoked effective August 8, 2007. Mr. Olds had been licensed since 1975. Mr. Olds' license to sell life, accident, health insurance, property and casualty insurance revoked by Director's Order from Hearing #07-HR-0074. The hearing was held regarding the Department's Order of Revocation dated December 19, 2006. The Order of Revocation was issued as a result of an investigation revealing Mr. Olds had sold an elderly person an annuity and universal life policy and then borrowed over \$70,000 from the policies. Mr. Olds used his position of trust in borrowing funds for his own financial gain and failed to repay them to the consumer.

Jack Dale Frame, Elmwood – insurance producer license revoked effective August 14, 2007. Mr. Frame had been licensed since 1973. Mr. Frame's license to sell life insurance revoked by Director's Order from Hearing #06-HR-0837. The hearing was held regarding the Department's Order of Revocation dated September 25, 2006. The Order of Revocation was issued as a result of an investigation revealing Mr. Frame had devised and participated in a scheme to defraud policyholders out of over \$71,000. The scheme involved changing policyholder's address of record to the licensee's address, making unauthorized withdrawals against annuities without knowledge or consent of the policyholders, then forging signatures and cashing withdrawal checks. Additionally, the Order required Mr. Frame to pay a \$15,000 civil forfeiture within 35 days of the date of the Order.

John Glenn Elliott, Highland – insurance producer license revoked effective August 17, 2007. Mr. Elliott had been licensed since May 16, 2006. Mr. Elliott was licensed to sell life, accident, health insurance, and variable insurance. Director's Order dated August 17, 2007, dismissed Hearing #07-HR-0065 regarding the Revocation of Mr. Elliott's license. The hearing

was to be held regarding the Department's Order of Revocation dated June 6, 2007. The Order of Revocation was issued as a result of an investigation revealing Mr. Elliott had violated insurance laws of another state, had his license refused in his home state, and failed to notify the Division of an address change within 30 days.
