**Springfield, Illinois** – Leonard A. Sherman, Director of the Illinois Department of Professional Regulation, announced the following disciplinary actions taken by the Department during the month of **January 2001**.

**ARCHITECTURE**

**Victor Dziekiewicz, Chicago** – architect license (001-010255) reprimanded and fined \$1,500 for practicing on a non-renewed license.

**COSMETOLOGY**

**Ahmed A. Metwally, Chicago** – cosmetologist license (011-244580) reprimanded and fined \$100 for practicing on a non-renewed license.
