Springfield, Illinois – Fernando E. Grillo, Director of the Illinois Department of Professional Regulation, announced the following disciplinary actions taken by the Department during the month of **August 2003**.

**ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS
AND STRUCTURAL ENGINEERS**

Charles E. Beck, Bothell, WA – professional engineer license (062-043853) placed in refuse to renew status after defaulting on an Illinois Student Assistance loan.

John Pavlovich, Lake Forest – ordered to cease and desist the unlicensed practice as an architect after he submitted approximately 235 residential permit applications and plans to the city of Chicago's Building Department using the name of a deceased architect.

BARBER, COSMETOLOGY, ESTHETICS AND NAIL TECHNOLOGY

Pro Nails, Mattoon – salon license (189-002801) reprimanded and fined \$250 for employing an unlicensed individual as a nail technician, and allowing salon staff to use a callous cutter on a client.

Tiffany T. Tran, Marion, and Rose's Nails, Marion – Tran's nail technician license (169-008229) suspended for two months followed by probation for three years and fined \$400, and Rose's Nails' salon license (189-004051) placed on probation for three years and fined \$800, for employing an unlicensed individual to practice as a nail technician, allowing employees to prescribe an ineffective solution for fungal nail infections, which is outside the scope of their license, and unsanitary conditions in the salon. Tran also violated the terms and conditions of a previously imposed probation by failing to document the completion of continuing education hours.

LANDSCAPE ARCHITECTURE

Ronald W. Rehling, St. Charles – landscape architect license (157-000117) reprimanded and fined \$500 for practicing on a non-renewed license.

MEDICAL

Ramon Fermin, Chicago – medical (036-066393) and controlled substance licenses indefinitely suspended due to habitual and/or excessive use of alcohol or drugs.

Ronald Freeman, Highland Park – ordered to cease and desist the unlicensed practice of medicine after treating patients with controlled substances for weight loss.

Richard A. Herbert, Naperville – medical (036-049799) and controlled substance licenses placed on probation for three years for failing to properly supervise an unlicensed employee.

Phil Cantillas, Chicago – ordered to cease and desist the unlicensed practice of nursing and ordered to pay a civil penalty of \$2,500.

Joyce Dees, Taylorville – licensed practical nurse license (043-066257) indefinitely suspended after being discharged from her nursing position during the probation period because she was unable to fill the requirements of the position.

Tammy Hoskins, Springfield – licensed practical nurse license (043-062738) indefinitely suspended after being found guilty of aggravated criminal sexual abuse of a minor and delivery of a controlled substance, both felonies, and failing to report the convictions to the Department.

Deborah F. Karalis, South Beloit – licensed practical nurse license (043-059345) indefinitely suspended for abandoning residents, leaving a medication cart sitting open in a hallway, taking three hours to do a medication pass, and requesting refills of controlled substances from emergency room doctors rather than from her attending physician, while employed at Park Ridge Terrace in Loves Park.

Suzanne Konow, Seattle, WA – registered nurse license (041-285506) revoked after being disciplined in California.

Debra Parnello, Rockford – licensed practical nurse license (043-076455) indefinitely suspended for diverting Vicodin for self-use while employed at Provena Cor Mariae in Rockford.

Deana Ridgeway, Paducah, KY – licensed practical nurse license (043-076118) indefinitely suspended for diverting Vicodin, Ativan and Lortab for self-use, and testing positive for hydrocodone during a drug screen, while employed at Good Samaritan Care Center in Metropolis.
