ARCHITECTS, LAND SURVEYORS, PROFESSIONAL ENGINEERS AND STRUCTURAL ENGINEERS

Manuel Palma, Chicago – land surveyor license (035-002135) fined \$250 for sealing a Surveyor's Certificate on a sheet of paper that was not a survey.
