## **BANK AND TRUST COMPANIES**

**Bank of Lincolnwood, Lincolnwood** – ordered to cease and desist from engaging in unsafe and unsound banking practices effective April 21, 2009.

**Alton Pawn Shop, Inc., Alton** – pawnshop ordered to pay a \$600 civil penalty for failing to file their 2008 Pawnshop Disclosure of Business Activities Report in a timely manner.

**C.B.J. Corporation, Chicago** – pawnshop ordered to pay a \$150 civil penalty for failing to file their 2008 Pawnshop Disclosure of Business Activities Report in a timely manner.

## **CONSUMER CREDIT**

**AAA Checkmate, L.L.C., Summit** – CILA license (2037) fined \$25,000 for failure to contain evidence of a contract signed or acknowledged by the borrower in the file.

**Oasis Legal Finance, LLC., Northbrook** – CILA license (2637) fined \$6,000 for improper simple interest calculations.

The Payday Loan Store of Illinois, Inc., Lyons – PLRA license (1336) fined \$9,750 for the following violations: lender did not obtain any official documentation of the borrower's income before making a payday loan, payday lender did not provide the required notice of the consumer's right to a repayment plan in a separate signed written document, and official income documentation was not the required type for a payday loan or was not for income for the 30 days preceding the loan.

**Midwestern Financial Corporation, Orland Park** – SF license (469) fined \$5,975 for the following violations: licensed location did not prominently display the hours of operation, improper simple interest calculations, licensee does not keep a separate, complete file for each obligor, licensee's or retail seller's name and address is not properly disclosed on legal document, wage assignment was accepted from borrower that contained blank spaces, and executed copy of paid contract or other legal document retained in file but not stamped "PAID IN FULL" or equivalent.

Illinois Catalog Sales, Inc. d/b/a ICS Loans, Joliet – CILA license (1890) fined \$5,575 dollars for the following violations: licensed location did not prominently display the hours of operation, the annual percentage rate is not properly disclosed, improper simple interest calculations, the loan contract does not accurately disclose the schedule of payments or the total of payments, the payment receipt does not accurately show the required elements, the payment record for a simple interest loan does not show the principal balance due, the date to which interest is paid or itemize other charges collected, and Truth in Lending box is not properly completed.

Advance America, Cash Advance Centers of IL, Inc. d/b/a Advance America, Cash Advance Centers, Mount Vernon – CILA license (1661) fined \$5,400 for failure to accurately show the required elements on the payment receipt.

**Devon Financial Services, Oak Lawn** – PLRA license (1496) fined \$4,050 for the following violations: the loan document or other legal instrument contains blanks, the file of original papers for the loan is not properly maintained, Licensee's or retail seller's name and address is not properly disclosed on legal document, evidence of a signed or acknowledged Truth-In-Lending disclosure is not in the file of original papers, lender did not enter into the database that the borrower's loan was paid in full or cancelled on the day the transaction was made, file does not contain evidence of a wage assignment signed by the wage earner, the lender made a payday loan but there is no evidence of a signed, written agreement, loans over 25% of borrower's income, and lender made a payday loan resulting in the borrower having a combined outstanding payday loan principal balances greater than 25% of borrower's gross monthly income.

**Devon Financial Services, Chicago** – PLRA license (1319) fined \$3,000 for failure to obtain any official documentation of the borrower's income before making a payday or title-secured loan.

**ACE Cash Express, Inc. d/b/a ACE Cash Advance, Rockford** – PLRA license (1409) fined \$5,000 for presenting dishonored check, ACH debit, or other item more than twice.

**Brother Loan & Finance Company, Summit** – CILA license (642) fined \$3,000 for failure to contain evidence of a signed or acknowledged Truth-In-Lending disclosure in the file of original papers.

**Illinois Lending Corporation, Orland Park** – CILA license (2577) fined \$2,250 for the following violations: licensee does not keep a separate complete file for each obligor and the payment receipt does not accurately show the required elements.

Wilshire Commercial Capital, LLC d/b/a Wilshire Consumer Credit, Los Angeles, CA – CILA license (3318) fined \$1,125 for failure to accurately disclose the finance charge.

**Express Title & Payday Loans, Inc., Wheeling** – CILA license (2071) fined \$2,000 for the following violations: the annual percentage rate is not accurately disclosed, the loan document or other legal instrument contains blanks, improper simple interest calculations, and false advertising: lender's advertising, signage or other promotional material uses the term "payday" but the examiner found that the lender does not offer payday loans.

**The Payday loan Store of Illinois, Inc., Oak Lawn** – PLRA license (1300) fined \$2,000 for making loans over 25% of borrower's income, lender made a payday loan resulting in the borrower having a combined outstanding payday loan principal balances greater than 25% of borrower's gross monthly income.

**Devon Financial Services, Oak Lawn** – CILA license (3212) fined \$1,900 for the following violations: licensee not operating under licensed name, security is not properly disclosed, and licensee's or retail seller's name and address is not properly disclosed on legal document.

**E-Loan, Inc., Pleasanton, CA** – CILA license (2664) fined \$1,650 for the following violations: licensee charged a fee not allowed and the disclosure of variable rate terms does not meet Truth-In-Lending requirements.

One Iron Ventures, Inc. d/b/a First Cash Advance, Dolton – PLRA license (1290) fined \$1,150 for the following violations: loans over 25% of borrower's income, lender made a payday loan resulting in the borrower having a combined outstanding payday loan principal balances greater than 25% of borrower's gross monthly income, and wage assignment was accepted from the borrower that contained blank spaces.

One Iron Ventures, Inc. d/b/a First Cash Advance, Matteson – CILA license (1533) fined \$1,500 for failure to properly complete the Truth-In-Lending box.

**Title Lenders, Inc. d/b/a USA Payday Loans, Collinsville** – CILA license (2680) fined \$1,200 for the following violations: the annual percentage rate is not accurately disclosed and improper simple interest calculation.

**Pronto Finance Group, LLC d/b/a Pronto Prestamos, Elgin** – CILA license (2954) fined \$1,200 for failure to contain the rule of 78 example on the loan contract.

**Personal Finance Company LLC, Joliet** – CI/SF license (637) fined \$1,050 for the following violations: the annual percentage rate is not accurately disclosed, the loan document or other legal instrument contains blanks, security is not properly disclosed, the loan contract does not accurately disclose the schedule of payments or the total of payments, and the payment schedule does not accurately disclose the first payment date.

**United Fast Cash Inc., Peoria** – CILA license (1571) fined \$1,050 for the following violations: the loan document or other legal instrument contains blanks, the file of original papers for the loan is not properly maintained, and security is not released.

**Injury Case Funding, St. Louis, MO** – CILA license (3224) fined \$1,000 for failure to contain evidence of a contract signed or acknowledged by the borrower in the file.

**QC Financial Services, Inc., Berwyn** – CILA license (2254) fined \$1,000 for failure to contain evidence of a contract signed or acknowledged by the borrower in the file.
